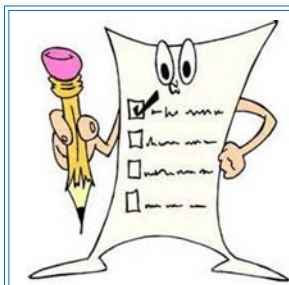

### Report of Changes to AAHP Documents

The standard operating procedures (SOPs) of the American Academy of Health Physics (AAHP) are reviewed periodically. Changes are proposed and approved during meetings of the AAHP Executive Committee.

Revisions to SOP 2.1.1 (Review of Appeals) and SOP 2.2.2 (Assigning Continuing Education Credits to Continuing Education Activities) were recommended and approved by the Executive Committee at the 2015 midyear meeting.

Although not required to be approved by the Executive Committee, SOP 6.2.4 (Good Things to Know Document for Secretary), SOP 6.2.7 (Good Things to Know Document for Parliamentarian), and SOP 6.2.15 (Good Things to Know for *CHP News* Editor) were also revised recently.
