### Exam Candidate Reactions

One of the agenda items which the ABHP considered in San Antonio was a compilation of the candidate feedback surveys from the 1996 Part II examination. Readers will probably relate to some of the comments which follow.

Regarding the test's adequacy as a reflection of professional responsibilities: "I think the exam was very fair when compared with the 1995 Part II. I had a few minor problems understanding some of the questions but it is really difficult to write the perfect exam. On the whole it was an adequate test."

Regarding the supporting information provided: "In real life, an HP would not rely on memory to solve an issue but rather would rely on memory to get the correct document to resolve the issue. A brute memory exam is not a real life situation and should be discontinued."
